1. LIFE EUROKITE

LIFE EUROKITE (LIFE18 NAT/AT/000048) is a cross-border protection of the Red Kite in Europe by reducing human-caused mortality. The red kite breeds exclusively in Europe and is endangered due to illegal persecution. Within LIFE EUROKITE, we aim to get to the bottom of the anthropogenic mortality reasons using telemetry and work to prevent them. Based on the results measures to counteract anthropogenic mortality will be implemented. Where suitable structures and/or organisations exist, the counteractions will as far as possible, collaborate with them. The range of measures goes from information campaigns, initializing legal prosecution and lawsuits (e.g. against poisoners) to voluntarily technical measures (e.g. from power line providers) and political / legal efforts (e.g. adaption of CAP schemes) and awareness actions.

Main project objectives:

- Significant reduction of impact of poisoning (reduction of the rate of poisoning cases by 5% on EU level)
- Identification and solving of problematic cases concerning electrocution / collision
- Reduction of other anthropogenic reasons of mortality
- Population reinforcement in Spain halts range loss and identifies the factors causing a decline of the populations, presumably associated with climate change.

Notice boards

The 5 planned notice boards were erected in 2022 and 2023 in the course of “30 years LIFE Programme”.

On the occasion of "30 years of the LIFE Programme" and the LIFE EUROKITE project, the opening of information boards of the LIFE EUROKITE project were celebrated in Germany, France, Spain and Austria.

LIFE (L'Instrument Financier pour l'Environnement) is the only EU funding program that exclusively supports environmental concerns. LIFE celebrated its 30th anniversary on May 21st. The program, which has existed since 1992, promotes measures in the areas of biodiversity, environmental and climate protection.

The LIFE EUROKITE project is also 60% supported by LIFE. LIFE EUROKITE is a cross-border and EU-wide project to protect the Red Kite (*Milvus milvus*) with the aim of reducing human-caused mortality. The red kite breeds almost exclusively in Europe and is e.g. threatened by persecution. Within LIFE EUROKITE, the anthropogenic causes of mortality are being investigated with the help of telemetry and work is being done to reduce them in the future.

In Austria, together with Mayor Gernot Haupt (Marchegg), Mag. Rainer Raab (Technical Manager LIFE EUROKITE), Ing. Werner Falb-Meixner (Chairman MEGEG, Vice President of the Burgenland Chamber of Agriculture), René Lobner (LEADER Region Marchfeld, Member of the Lower Austrian Parliament), Mag. Margit Bruck-Friedrich, M.A. (Ambassador, Austrian Embassy Pressburg), Mag.a Viktoria Hasler (representing Leonore Gewessler, BA Federal Minister BMK) and Provincial Councilor Martin Eichinger (representing Governor Johanna Mikl-Leitner), on May 21, 2022 the LIFE EUROKITE information board at Marchegg Castle unveiled during the Marchfeld Region Festival and the Lower Austrian State Exhibition.

Together with the “Rotmilanzentrum am Heineanum” (red kite center at the Heineanum) in Halberstadt (Germany), an information board of the LIFE EUROKITE project was also opened on June 24th, 2022.

The main goal of the red kite Center is to stabilize the red kite population in the state of Saxony-Anhalt (Germany). For this to happen, however, other medium-term goals must also be achieved. This includes, for example, the establishment of the center as a (nationally and internationally) recognized advice and information center for the red kite. Closing existing gaps in knowledge and monitoring the nationwide population of red kites is also one of the goals that they want to achieve.

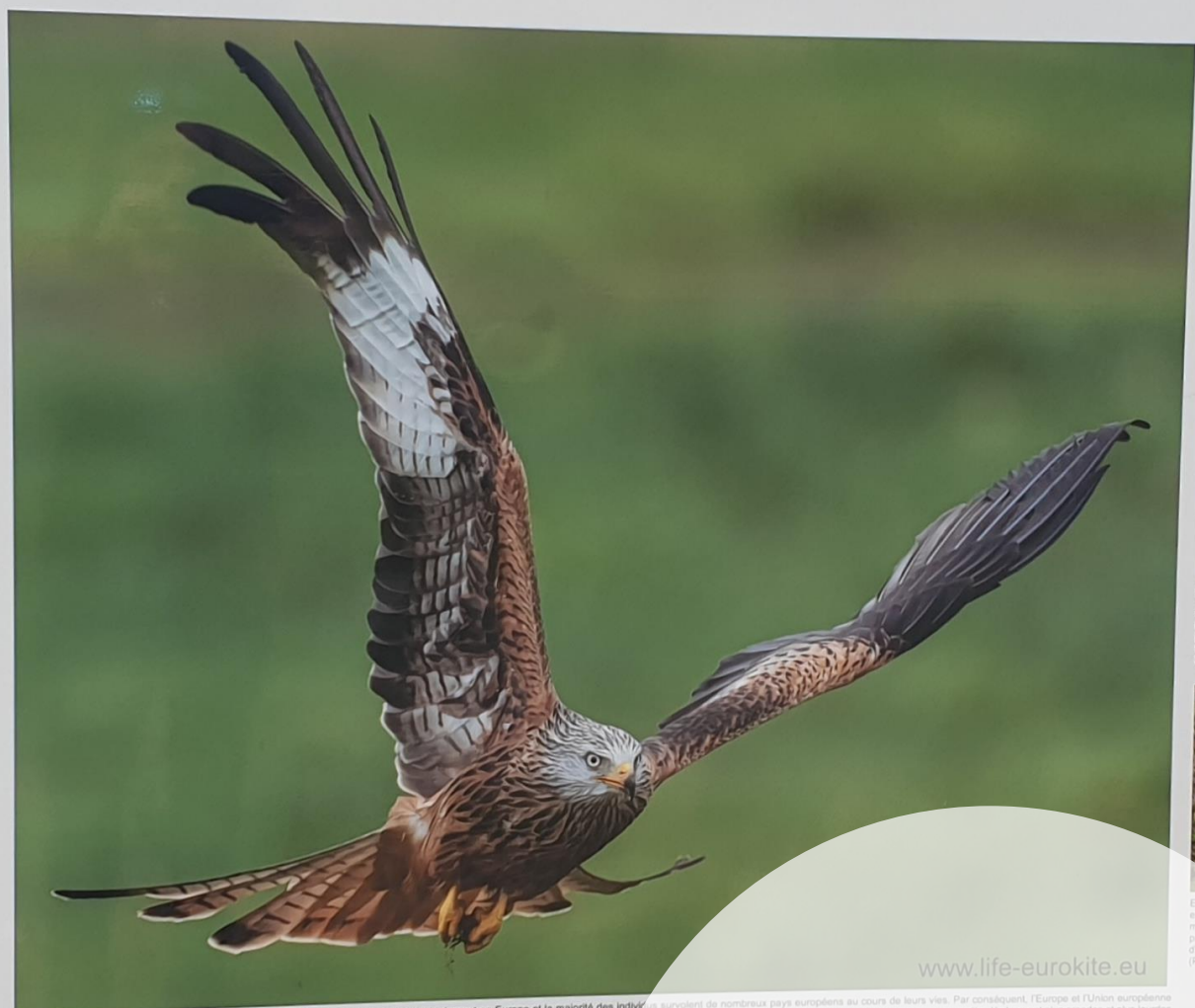
Together with the LIFE EUROKITE projects, several red kites are also being tagged and tracked in Saxony-Anhalt.

AGIR pour la BIODIVERSITÉ

The Minister of Agriculture, Livestock, and Sustainable Development of the Extremadura Regional Government, Mercedes Morán, has inaugurated the informative signboard of the LIFE EUROKITE project in Valencia del Mombuey (Badajoz) on 22nd December 2023. With this action, AMUS wants to express gratitude and recognition to the municipality of Valencia del Mombuey for all the support received from its mayor and residents in the development of biodiversity conservation projects, particularly the release of red kites in the reinforcement action for the population of this threatened species in the Southwest of Spain. The release takes place in the municipality of Valencia del Mombuey.

Following the presentation of the informative panel, along with residents and students from the public school Santa Margarita in Valencia del Mombuey, a red kite rehabilitated at the AMUS Wildlife Hospital was released. This red kite was equipped with a GPS transmitter from the LIFE Eurokite project, which will not only allow for tracking but also provide students from this school with an opportunity to study the movements of this kite across various European countries.

AMUS expresses gratitude for the support received from the current Minister of Agriculture, Livestock, and Sustainable Development of the Extremadura Regional Government, as well as from the mayor of Valencia del Mombuey, Manuel Naharro, for the projects that AMUS carries out in Extremadura, particularly the LIFE EUROKITE project.



Campaign against poisoning

The first meeting to discuss possible Campaigns against poisoning took place on the 5th of October 2021. A general data collection of poisoning cases in whole Europe is ongoing and the first campaigns will start in 2024 to raise more awareness. The focus will be on country and regions with a high rate of poisoning cases.

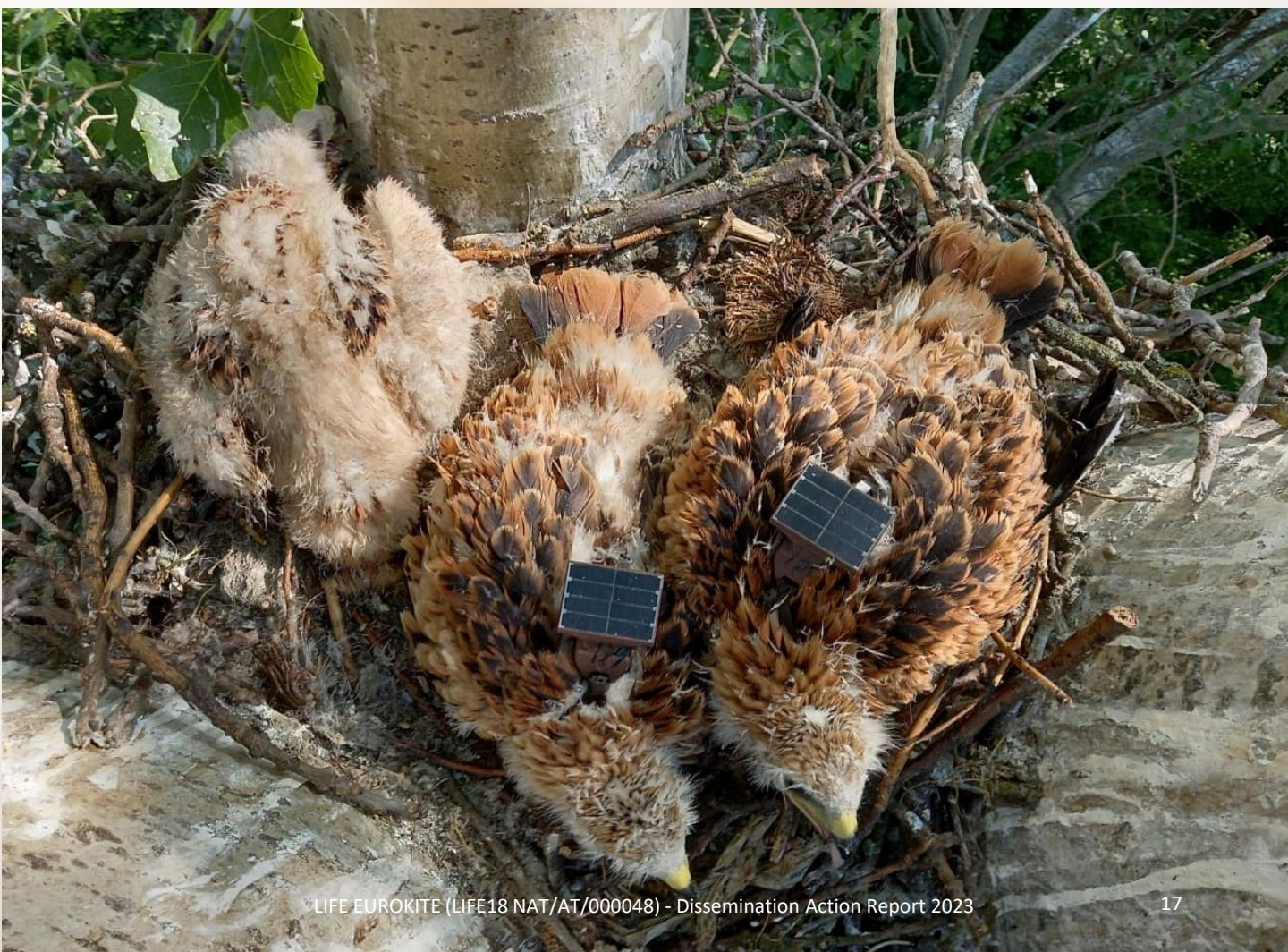

Scientific conferences / workshops

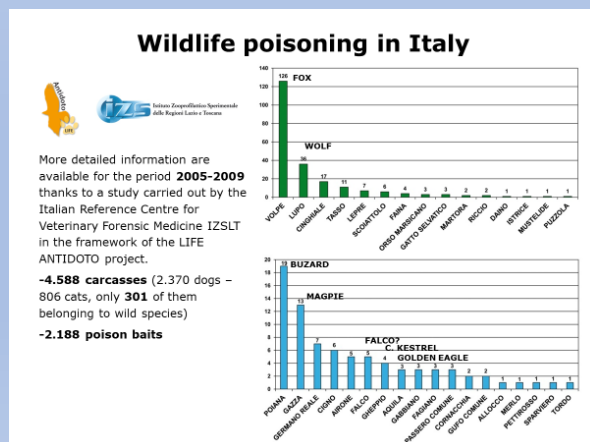
The workshop “Tagging technology” was held on the 8th of April 2020, 18 Participants from the project consortium. After a presentation of the technical requirements and possibilities a preliminary decision was taken to use ANITRA loggers for 2020. (After the workshop a price comparison of 4 comparable devices was done and the ANITRA product was the technically best and also the cheapest).

The workshop “Actions against illegal Poisoning” was held on the 12th of November 2020, 83 Participants, 3 welcome speeches, 8 keynote speeches. Good overview of poisoning situation and past / ongoing initiatives.

The workshop “Power Lines” was held on the 2nd of December 2020, 21 Participants, 6 keynote speeches. Good overview of experience and available materials. Methods and materials have to be decided on a case by case basis.

The Workshop “Overview of wildlife poisoning in whole Europe” took place on the 11th of November 2021 in which 94 people from 13 different countries and around 40 different organizations and projects took part. The workshop was opened by Werner Falb-Meixner, the chairman of the Central European Society for Raptor Protection (MEGEG) and the Members of the European Parliament Thomas Waitz (Group of the Greens/European Free Alliance) and Michal Wiezik (Group of the European People's Party - Christian Democrats).

Conference: Shared airspace - Towards a Bird-Friendly Power Grid

On September 28, 2022, RGI (Renewables Grid Initiative) and NABU (Nature and Biodiversity Conservation Union) together with seven German power grid operators invited to the event "Shared Airspace: Towards a bird-friendly power grid" in the Dortmunder U. The LIFE EUROKITE project was also invited to present the experiences of the project. Together with Amprion GmbH, one of the partners of the LIFE EUROKITE project, bird protection in the power grid in Germany, but also beyond national borders, could be further developed. The conference was about anchoring bird protection in the debate about environmentally friendly grid expansion and equally about uncovering hurdles and ways of implementation.

The forthcoming expansion of renewable energies is consequently accompanied by the expansion of the power grid. Herein lies the opportunity to enter into dialogue and bring together various interests for the energy transition and species protection.

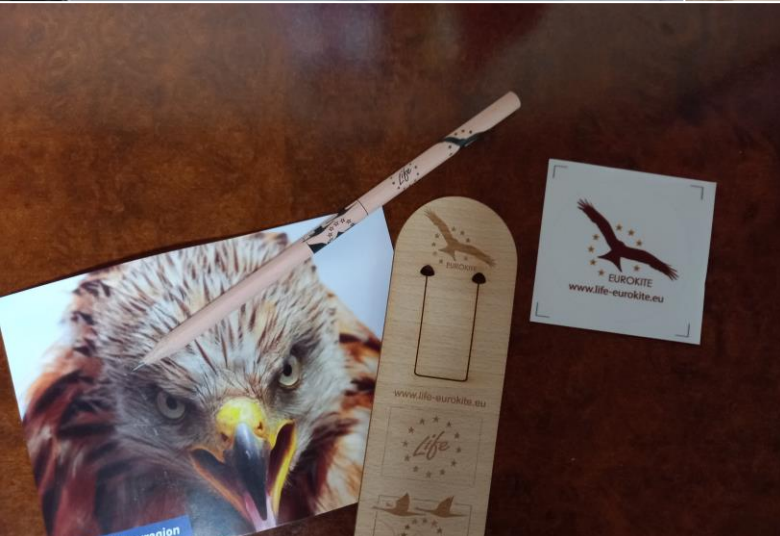
The LIFE EUROKITE project was selected for the printing of 200 postcards by #EUinmyRegion, which will be used for promotional material.

Publication of the book „Der Rotmilan in Europa - Erfolgreicher Schutz auf internationaler Ebene“ (The Red Kite in Europe - Successful protection at international level)

Hainburg an der Donau. On May 24th, 2022, during the Austrian Power Grid AG (APG) symposium "Sustainable habitat management - Biodiversity and Species Protection on power lines", the book "The Red Kite in Europe - Successful Protection at international level" was published.

In addition to a large number of fantastic pictures, the book offers the reader background information on the red kite, its habitat and distribution as well as its main threats. There are many different conservation efforts for the red kite across Europe. In addition to governmental organizations and non-governmental organizations, there are numerous smaller and larger projects to protect the red kite and other raptor species. The international statements by organizations and scientists in the book show the meaning and importance of cross-border cooperation between all different interest groups.

The costs for image fees, parts of the text creation and the entire printing costs were financed by Austrian Power Grid AG (APG). Parts of the text were created as part of the LIFE EUROKITE project (LIFE18 NAT/ AT/000048), which is funded 60% from the LIFE Nature Fund. APG will provide a total of 1,500 copies for stakeholders to the LIFE EUROKITE project.

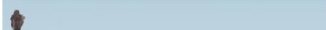

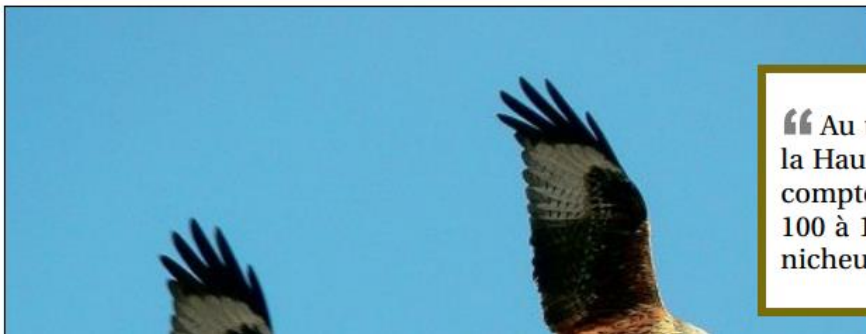

Webcam operated by SEO/BirdLife

The webcam operated by SEO is online since November 2020. It was integrated into the website of LIFE EUROKITE and is also available on YouTube (SEO and LIFE EUROKITE).

SEO/BirdLife has a great experience in the installation of webcams in nature for the observation and dissemination of bird biology. Prior to the definitive installation and the start of the broadcasting, several arrangements were made with the managers of the feeding place (Fondo de Amigos del Buitre), the owner of the land (Binaced Town Council), and the regional government (Environmental Service of the Huesca Provincial Service of the Aragon Regional Government). The Fondo de Amigos del Buitre is a local association that manages several feeders and it is a fundamental part of this webcam: they are in charge of keeping the feeding place where the camera is located in good conditions, making the daily food supply, and solving possible local problems with the installation for its correct functioning. The town council granted permission to place the webcam on land it owns, and collaborated in part of the necessary infrastructure, such as the installation of the wooden post on which the camera is located. Finally, the Environmental Service of the Huesca Provincial Service approved the installation of the webcam to broadcast images of endangered species over the Internet, but did not consider it necessary to draw up a written permit. This webcam is located in Las Pichillas feeding place (Binaced, Huesca, northeast Spain), and is one of the oldest controlled feeding places for scavengers in Spain.

Since the launch in mid-November 2020 the webcam had by now (12/2023) 180.000 views. Some videos have been included in [SEO/BirdLife YouTube channel](#), with thousands of views.

Webcam operated by CERM in Italy

The webcam operated by CERM was online from August 2021 to the end of 2022 . It was integrated into the website of LIFE EUROKITE and is also available on YouTube (CERM and LIFE EUROKITE). Now only a few videos are online which show the feeding place.

This webcam is part of one of the three cameras available in the LIFE EUROKITE project within its actions for public awareness and dissemination of results. The action has been carried out thanks to the support of CERM and the financial support of the Austrian Power Grid (APG). The CERM Endangered Raptors Centre is located in Southern Tuscany (Italy) and managed by the CERM Association. The CERM was the core area of a Red kite reintroduction programme which was carried out in the framework of the LIFE Save the Flyers project between 2007 and 2014, based on the translocation of 105 young red kites from two donor countries (Corsica, France and Canton of Fribourg, Switzerland). The programme was successful and led to the establishment of a self-sustaining Red kite population, which now is expanding in the surrounding areas.

At the end of February, the red kites, which have flown south to overwinter, begin to migrate back to their breeding areas. Now it's time to find the right nest, possibly the same nest from last year, expand and repair it a bit and start breeding with the right partner.

But what exactly happens at the nest, who comes to visit and, most importantly, will it be a successful brood? With the help of a small camera it is possible to partially answer these questions. And this is exactly where the story of a nest in North Rhine-Westphalia in the Lippe district begins.

The LIFE EUOKITE project was contacted by employees from Bielefeld University with the background that a tagged red kite was breeding nearby in 2021. Since red kites often use the same nest in the following years, hope was raised that the tagged red kite would breed in this nest again in 2022. So it was decided to install a camera on this nest.

Tagging of the red kite

The tagged red kite "Valencia" was tagged in Spain at the AMUS wildlife station in 2019 after she was found with signs of poisoning and nursed back to health. Valencia was released on November 29, 2019 by Duncan Orr-Ewing (RSPB), Richard Saunders (National Wildlife authority UK, Natural England) and the Mayor of Valencia del Mombuey, Manuel Naharro. Originally, Valencia probably comes from Germany, because soon she started the way back to the breeding area in the district of Lippe, where she spent the breeding season. In 2021/2022 Valencia spent the winter in southern Spain again.

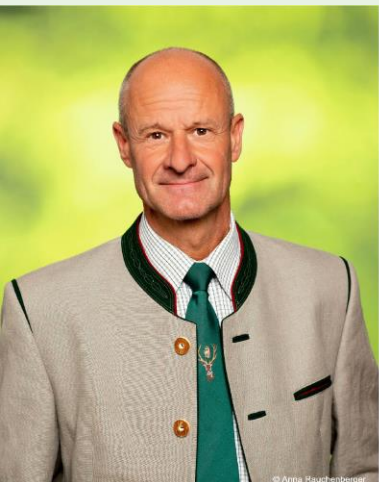
Networking

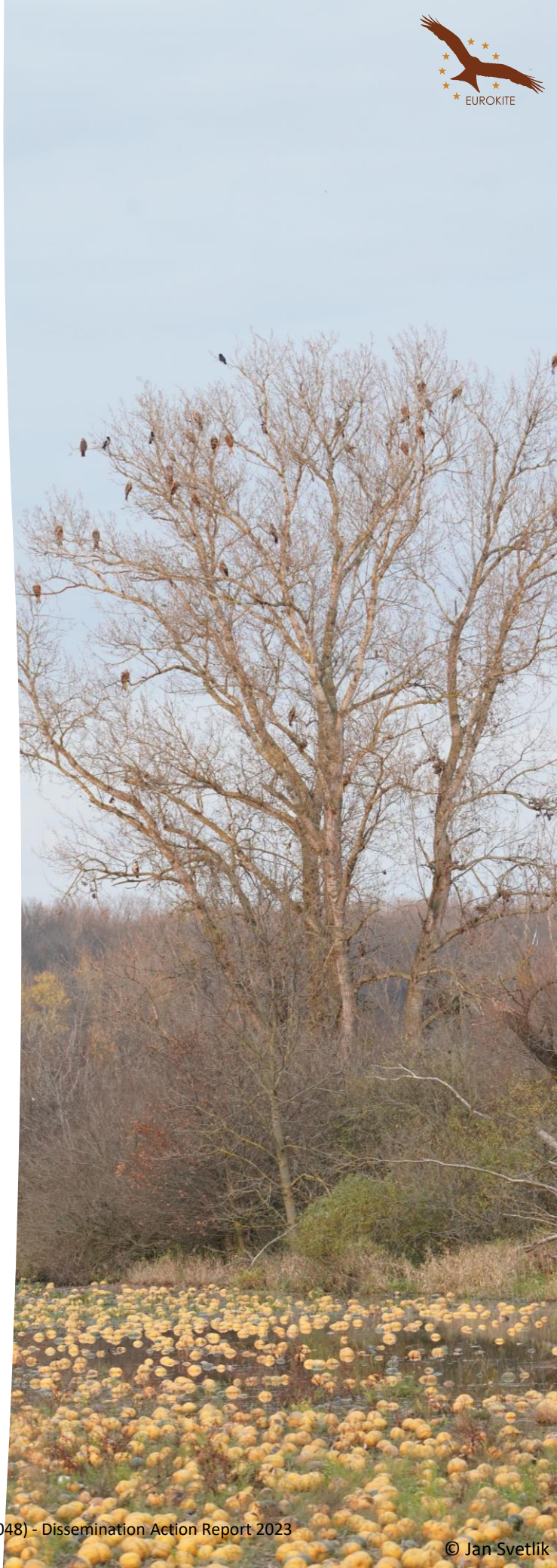


Red Kite Conservation Team (RKCT)

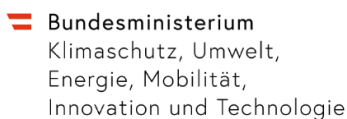
